Alongside her colleagues, she was also responsible for conducting Principal meetings and planning effective professional learning for Principals and Teachers for sustained growth. She has participated in the development of action plans which have generated funding for Board initiatives. She has also served as principal of several schools in the District of Timiskaming, and as a Teacher at several grade levels.

Through her leadership capacity, she represented the Board's interests with the Best Start Network Committee, the Office of the Secretariat for Literacy and Numeracy, EQAO, and the Staff Development Council of Ontario. Within our system, she has taken on several portfolios, most notably the Managing Information for Student Achievement (MISA) initiative, the Healthy Active Schools initiative, the Beareavement/Tragic Events Committee, and the Balanced Literacy Framework. Throughout her teaching career, she has acquired several specialist designations including Special Education and Religious Education and completed the Principals' Certification. Most recently, she has successfully completed four modules of the Supervisory Officers Qualification Program.

Martin Drainville, Trustee in the Haileybury/New Liskeard/Cobalt area, is confident that Rowe measures up to the expectations of this more demanding role within the NCDSB. "Her sense of genuine concern for the students within our system drives her to constantly seek to improve instructional approaches in our classrooms," stated Drainville. "She is a dedicated professional who is committed to the betterment of Catholic education, both in terms of academics and faith development."
