ELECTION OF VICE-CHAIR

6. Roles and Responsibilities of SEAC

Tricia Stefanic Weltz mentioned that SEAC members will be involved in a meaningful way in the preparation of the Board's annual plan and in the annual budget process. The next meeting will be dedicated to the SEAC rules and regulations, a document shared at the September meeting. Kay Gaffney stated that Tricia and Dan are doing a fantastic job of bringing the members up to date with all Student Services projects.

7. Essential Skills Classroom at St. Paul School

The Board has approved the opening of an Essential Skills Classroom at St. Paul School which is specially designed for children with developmental disabilities and exceptionalities. It will be a place where students can receive life skills, practice and implement them, and learn to function in this society. The Board will be posting for a Teacher position along with an Educational Assistant to support specific needs of the classroom. Kay Gaffney congratulated Tricia and Dan for her work on this important program and commended the Board members. Fred Salvador stated that the trustees will have the opportunity to visit the classroom in the near future.

8. <u>Provincial Demonstration Schools Partnership</u>

Dan Loreto has been seconded by the Ministry of Education's Provincial Demonstration Schools branch, where he will be trained to deal with students who have severe learning disabilities. Dan explained to the members that it is difficult for northern children to access Trillium, a residential-type community that takes interventions and applies them to children. Accommodations and travel is provided but the children leave home five days a week. Dan's responsibility now is to take the training and replicate it in the North, an essential benefit to the Board.

9. <u>CODE Update</u>

Tricia Stefanic Weltz attended a provincial forum in Toronto on October 30th where the participants shared last year's CODE results. She added that we are right on track and she will share with the team information on how to sustain great elements of instructional capacity and achievement. Kay Gaffney congratulated the team who implemented this project.

10. <u>Agency Reports</u>

Kay Gaffney indicated that the Lions Quest has established a pilot project on prevention and antisocial behavior in nine of Grade 7 classes across the region. She added that ISNC has implemented a health component. For more information on this and other components, we could ask a representative of ISNC to make a presentation at a future meeting.
