Timmins Family Counselling Centre has received a high number of family referrals. Natalie Parnell stated that North Eastern Ontario Family and Children's Services are contacted first, and then the families who do not have any support or benefits are put on a six-month wait list to start counseling.

Staffing changes were held at the Children's Treatment Centre over the summer. Annie Demers is the new Clinical Services Manager. Occupational Therapist, Erin Millette (Poytress), is currently on a maternity leave and is being replaced by Valérie Croisetière. Karina Lacroix is returning to the Occupational Therapy position. Physiotherapist, Karim Suleman, will be working in Moose Factory, Moosonee and further up the coast depending on the James Bay Special Needs Strategy plans.

The North Eastern Ontario Family and Children's Services has launched their annual Purple Ribbon Campaign. People are being encouraged to wear purple t-shirts this year to bring awareness to child abuse and neglect. A walk from NEOFACS to Gillies Lake is scheduled on October 2<sup>nd</sup>.
