Date: September 29, 2025

Length: 60 minutes

Topic 1: Keeping Students Safe – School Board Police Protocol and School Board Support Services

Entity Hosting: All Schools

Presenter(s)/Facilitator(s): Facilitated by the School Principal

Description: All staff will engage in a review of the School Board-Police Protocol to understand local responsibilities around police involvement and interaction in schools. This learning will also highlight procedures relating to suspension and expulsion, and student incidents that require police involvement. A review of the NCDSB School Support Services webpage will be used to clarify available services for students and staff, and how to request support. Schools will also discuss local processes to identify needs and create interventions to support students with behavioural needs through the School-based team meeting process.

Topic 2: Keeping Students Safe – Suicide Intervention and Human Trafficking Protocols

Entity Hosting: All Schools

Presenter(s)/Facilitator(s): Facilitated by the School Principal w/ resources prepared by the Supervisor of Mental Health and WellBeing

Description: All staff will engage in a review of local protocols to respond to and support students with suicide risk and human trafficking concerns. A focus on clarifying school staff roles and community partner roles will ensure staff understand how to respond effectively and how to seek appropriate support. The session will include a review of potential warning signs to support early intervention.

Length: 70 minutes

Topic 5: Keeping Students Safe - Bullying Awareness and Prevention

Entity Hosting: Schools

Presenter(s)/Facilitator(s): Facilitated by the School Principal w/ support from Mental Health and Well-being Staff

Description: All staff will review school board climate survey data to understand student experiences with bullying in schools and to identify potential areas for improvement. Available resources and programs will be highlighted, with the goal of supporting local school plans and interventions. School teams will also plan activities to engage students in learning about bullying prevention and intervention.

Topic 4: Promoting Student Success

Entity Hosting: Schools

Presenter(s)/Facilitator(s): School Principal and School Improvement Team Members

Description: School teams will review their current Student Achievement Plan, identifying progress made in the first month of school and identifying immediate next steps to support continued growth towards identified goals. All teachers will then complete their Annual Learning Plans to identify personal goals and learning opportunities for the school year.
