As part of the back-to-school plan, the government has asked school boards to work with local Public Health Units to add school-day vaccination clinics for students during instructional hours.

Providing Informed Consent

Please read, sign and return the <u>consent form</u> and <u>screening</u> <u>questionnaire</u> to have your child participate. Anyone getting the COVID-19 including children and youth, must provide informed consent. Informed consent means that you understand:

- what the vaccine involves (i.e. potential side effects)
- why it is recommended
- the risks and benefits of vaccination
- personal medical history

No child aged 5-11 will be vaccinated in a school day clinic without parental consent. As these clinics will take place during the school day, parents/guardians cannot be present. The school and local public health unit will support all students participating and create a safe, inclusive and welcoming environment.
