WHEREAS the Board and the District School Board Ontario North East, the Conseil scolaire catholique de district des Grandes-Rivieres, and the conseil scolaire public du Nord-Est de l'Ontario (collectively, the "Boards") have limited resources for the transportation of their pupils;

WHEREAS the Boards have, since their establishment, made agreements for the joint transportation of their pupils;

WHEREAS the Boards make such agreements for the joint transportation of their pupils in order to use available funds as efficiently as possible;

## **G.4.3** Transportation

WHEREAS the Boards need to implement as early as possible any measure allowing them to reduce the costs of transporting their pupils;

WHEREAS the Boards have established a Joint Transportation Committee (the "Committee") who was mandated to coordinate the optimization of all bus routes across the district based on students demographics data;

WHEREAS MicroAnalytics is a leading software company in the field of school bus routes optimization, and is recognized as such by the Ministry of Education of Ontario and other Ontario school boards;

WHEREAS MicroAnalytics has developed a software called Bustops, which facilitates the optimization of school bus routes, and which has been successfully used in Ontario in the past;

WHEREAS MicroAnalytics has trained one or several employees of the Boards in the proper and reasoned use of the Bustops software;

WHEREAS certain events which occurred during the 2003-2004 school year have made clear the urgent need to optimize school bus routes in the Kapuskasing and Hearst areas;

AND

HAVING REVIEWED the Committee's proposal for the optimization of the transportation of pupils in the Kapuskasing and Hearst areas for the 2004-2005 school year, which will enable the Boards to realize savings and reinvest funds in the transportation of pupils;
