#### 1. <u>Opening Prayer</u>

Kay Gaffney, Chair, welcomed everyone and led the group in a prayer. She also took the opportunity to welcome Tricia Stefanic Weltz as the new Program Principal for Special Education.

#### 4. Meetings Schedule 2006-2007

The Meetings Schedule 2006-2007 provided was accepted by the members.

#### 5. <u>Goals for Special Education 2006-2007</u>

Tricia Stefanic Weltz outlined the four (4) major areas that the Special Education team is looking at this year: coordination of services, program delivery, communication and professional practice, and alignment of Maplewood and Ministry reporting.

#### 6. <u>Recruiting New Members</u>

SEAC is seeking parent representatives from the Tri-Towns, Cochrane and Kirkland Lake. A letter will also be sent to the aboriginal community and those who are not present today will be contacted.

#### 7. <u>Resignation Letter</u>

Kay Gaffney read a letter from Alana Loreto informing SEAC of her resignation. A reply letter has been sent to her expressing our appreciation for her interest and input.

#### 8. <u>Request for Department Name Change</u>

A request to change the department name from Special Education to Student Services was expressed by Tricia Stefanic Weltz. She explained that the department is trying to move into a different direction losing the stigma that is sometimes attached to special education. The Board wants to connect curriculum and special education while working with all children. Following some discussion, it was agreed to change the department name to Student Services.

#### 9. <u>Special Education Funding</u>

Some members expressed their concern regarding the Special Education funding. Karen Rowe and Tricia Stefanic Weltz assured them that the Board is meeting the needs of all children. It was recommended that all parents with personal issues contact Tricia Stefanic Weltz.

### 10. <u>CODE Project Proposal</u>

The Board received \$200,000 last year to support the CODE Project. Sacred Heart School in Kirkland Lake and Holy Family School in Englehart received extensive support last year. Tricia Stefanic Weltz announced that the Board has applied for additional money. The funds will ensure the assistance of a Special Assignment Teacher (Dan Loreto), and assistive technology training will continue. Schools with a high population of students with special needs will be identified. Tricia will share the project when the proposal is finalized.

# 11. <u>Agency Reports</u>

Joel McCartney announced that the Cochrane Temiskaming Resource Centre will celebrate their 30<sup>th</sup> Anniversary on Friday, September 29<sup>th</sup>. Special events will be held at Northern College beginning with a presentation from a motivational speaker.
