1. Welcome and Prayer

2. Approval of Agenda

3. Approval of Minutes

4. In the Spotlight – Sacred Heart School, Kirkland Lake

We welcomed Shana Bates (Resource Teacher), Lorraine Davies (Educational Assistant), and Clayton Wabie (student) to the meeting to share the successes they have achieved this year with effective transitioning efforts. They recently hosted an evening for families from St. Jerome School and Clayton was able to help the younger students and their families learn first-hand what opportunities await transitioning efforts.

5. <u>Summary of Psychological Services</u>

Catherine Hoven reported that a total of forty-five (45) assessments will be completed by Dr. Tom Boniferro across the board this school year. All assessments done so far have come back with clearly defined exceptionalities. The assessment reports will be used to help develop effective programs on student Individual Education Plans (IEP) in the future.

6. <u>Parent Engagement Update</u>

A parent satisfaction survey, which provides parents with questions on topics ranging from instructional support, IEP development, parent input, agency collaboration, transition planning, and the use of assistive technology, has been created to help to continually improve our special education programs and services. The survey will be sent out in early June, and then returned to the Board for analysis. The results will be used as part of the development and measurement of the Board Improvement Plan for Student Achievement (BIPSA) and the Special Education Plan.

7. Mental Health Update

Regrettably, we have been unsuccessful in our recruitment efforts for a Mental Health Leader. It is expected that the NCDSB will achieve greater results in this strategy during the 2013-2014 school year.

8. <u>Transition Planning for Students with Autism Spectrum Disorder</u>

PPM 140 requires school boards to support their use of applied behavior analysis (ABA) as an effective instructional approach in the education of many students with autism spectrum disorders. Behaviour & Autism Disorder Specialist, Geneviève Lemieux, will be travelling to all schools requiring support and to put an effective transition plan in place with the assistance of resource teachers, classroom teachers, and educational assistants. The plan will be shared in June. We need to focus on improving transition planning now, since in 2013-2014, boards will be required to create a transition plan for all students on an Individualized Education Plan.

9. <u>Student Support Leadership Update</u>

A one-day workshop to learn more about child and youth mental initiatives, facilitated by the Student Support Leadership Cluster #14, are offered at four sites:

- Monday, May 27th in Kapuskasing
- Tuesday, May 28th in Englehart
- Wednesday, May 29th in Timmins
- Thursday, May 30th in Moosonee

The sessions are free for school board and agency employees.

10. M.A.C.S.E. Minutes

The minutes for the meeting of the Minister's Advisory Council on Special Education of February 6, 2013 were shared with the members.

11. <u>Special Education Plan – Motion of Approval</u>

A checklist that identifies components of the Special Education Plan that include amended information in regards to the special education programs and services will be submitted to the Ministry of Education by July 31, 2013. The amendments to the Plan were accepted by way of motion.
