4. **EQAO Results**

A summary of the 2017-2018 EQAO results was shared by Daphne Brumwell. There is slow and steady progress in Grade 3 and a slight increase in Grade 6 reading. There continues to be concern about the results in mathematics in both divisions and with writing at the junior level. The results of the Grade 9 Applied Math showed that we are holding relatively steady in terms of achievement over the last year, however we are still well below the provincial standard. The Ministry of Education has invested funding to help support mathematics across the province. Students must pass the Ontario Secondary School Literacy Test (OSSLT) in Grade 10, 11 or 12 as this is a graduation requirement, or take the Ontario Secondary School Literacy Course (OSSLC). For the most part, females in elementary schools are doing better than males. There is a significant gap between secondary girls and boys in math. Daphne is pleased with the success of the special education students, scoring higher than the provincial average on most elementary assessments. Interesting conversations are happening across the board regarding assistive technology. Students are using technology up until grade 8 but not as much at the secondary level. There is a need to help educate teachers about the nature of their disabilities. Resource teachers are starting conversations with their students. It was suggested to create a focus group for parents to help them advocate for their children.

5. **Autism Spectrum Disorder Pilot**

Special Assignment Teacher, Katie Mundle, gave the members a brief update of the Autism Spectrum Disorder Pilot. Last year 15 support staff participated in the 40-hour training course. Teachers, educational assistants and child and youth workers took part in an online registered behaviour technician course provided by the Geneva Centre for Autism. After participating in professional development sessions with Board Certified Behaviour Analyst, Kim Morris, and Psychometrist, Alexandra Freeman, they are feeling more comfortable in their work with our students. The program will continue again this year with the focus on training all our child and youth workers.

6. **New Students**

Catherine Hoven shared that there are 35 new identified students this year – 11 in our southern schools and 24 in our northern and central schools. 10 out of 35 students were transferred to us from other boards. Their identifications range from learning disabilities, language impairment, behaviour, physical, autism spectrum disorder, deaf, and multiple complex needs.

A letter from Peterborough Victoria Northumberland and Clarington Catholic District School Board was shared. Special education funding is always problematic as we see a rise in student needs, particularly with our younger learners.

Sharon Pountney announced that she will be retiring at the end of December. The agency will select another staff member to replace her on SEAC.
