# **POLICY STATEMENT**

## **POLICY REGULATIONS**

- 1.0 Provide for the oral administration of medication that has been prescribed for use during school hours and/or during school sanctioned supervised excursions, and where administration has been requested in writing by the parent/guardian, and confirmed by a medical practitioner.
- 2.0 Work in collaboration with community partners to secure services that must be provided by registered Health Practitioners under the Ministry of Health. These services include but are not limited to:
  - i) the injection of medication;
  - ii) catheterization;
  - iii) manual expression of the bladder/stoma;
  - iv) postural draining/suctioning;
  - v) tube feeding;
  - vi) physiotherapy;
  - vii) occupational therapy; and
  - viii) speech pathology.
- 3.0 Provide services related to lifting and positioning, assistance with mobility, feeding, toileting, and general maintenance exercises as prescribed by a Physiotherapist or Occupational Therapist, and speech correction and remediation as prescribed by a Speech Pathologist by trained board personnel.
- 4.0 Comply with all appropriate legislation pertaining to student health care and privacy information management.
- 5.0 Ensure consistency in the delivery of health support services in the school setting in accordance with Program Policy Memorandum. The NCDSB requires school staff, under the direction of the school principal, to provide appropriate health support subject to the respective administrative procedures and other related emergency provisions.
- 6.0 Administrative procedures and guidelines will be developed and revised as necessary to ensure standards of practices are established in all matters relating to the Provisions of Health Support Services in schools.
